



# STRATEGIC IMPLEMENTING PARTNERS FACT SHEET Gender-Based Violence Workstream





## **Project Brief**

The United Nations Population Fund (UNFPA Cambodia) and UN Women are implementing "Strengthening the prevention and coordination of Gender-Based Violence (GBV) services and support to four Provinces", a complementary five-year programme under ACCESS 2. Key actions include: strengthening case management via a comprehensive coordinated case management system trialled and implemented in two provinces; improving quality multi sectoral coordination of essential service through leveraging United Nations Module 5: Coordination and Governance of Coordination of the Essential Services Package (ESP); and addressing specific cultural and social dynamics, through working in partnership with the Ministry of Women's Affairs (MoWA) and key ACCESS 2 partners to develop prevention model(s) to be piloted in one identified target province. In doing so, the project will utilise existing secondary data analysis of good practices as well as lessons learnt on prevention initiatives in Cambodia to identify effective and contextual model, also building on the learnings from the RESPECT Framework and guidance from the Southeast Asia Centre for Prevention of GBV and other experts.

## **Project Outcomes**

Outcome 1: By 2028, select service providers deliver higher quality GBV and disability services to increasing numbers of people in the target provinces.

Outcome 2: By 2028, select national and sub-national policy and planning processes respond to the priorities of survivors of GBV and people with disabilities.

## **Key Activities**

Output 1: Build capacity of strategic partners and the Royal Government of Cambodia (RGC) to coordinate with one another to train frontline service responders in target provinces: Key activities include strengthening the





capacity of service providers on health sector response to GBV and multi-sectoral coordination at the national and sub-national levels.

Output 2: National guidelines and standards for service delivery are developed and disseminated in target provinces: Key activities include taking stock of the current progress on the GBV case management, developing standard of operation procedures (SOPs) for case management, strengthening the capacity of MoWA and MoH on the case management and monitoring of quality essential services.

Output 3: Robust referral systems are designed and delivered to service providers to raise awareness and ensure utilisation of GBV, physical rehabilitation and social protection services: Key activities include conducting an assessment on the coordination mechanism and developing Term of Reference (TOR) and SOPs for enhancing coordination mechanism at the national and sub-national levels.

Output 7: Pilots of new models for quality delivery and designed, assessed and disseminated to ACCESS partners, including new models for GBV prevention: Key activities include conducting an assessment on GBV prevention work applying the RESPECT framework and co-creating a primary GBV prevention model for piloting in one target province.

Output 8: Monitoring, feedback and data management mechanisms on select services developed and trialled: Key interventions include taking stock of existing data management systems, developing recommendations on data management system based on sub-national process, and technical support to MoWA/Technical Working Group-GBV (TWGG-GBV) to improve annual planning and reporting against NAPVAW IV implementation.

#### Beneficiaries

Direct beneficiaries include women and girls in the target provinces that are at-risk or subject to GBV including the most at risk and marginalised, frontline service providers and GBV case workers.

Indirect beneficiaries include people living in the communities where the project is implemented.

### **Geographic Location**

National level (Phnom Penh), Kampong Cham, Kampong Speu, Ratanakiri (in cooperation with CARE) and Siem Reap province.

#### **Project Partners**

Key line ministries, MoWA, the Ministry of Health, and collaborative and implementing Civil Society Organisation (CSO) partners (prevention), and UNICEF.
